Minutes of the meeting of BIDDENHAM PARISH COUNCIL held on 15th June 2021 at 7.30pm in Biddenham Pavilion.

MINUTES

- 1 Apologies for Absence: Cllr Alan Jacobs. Absent: Cllr Joe Warren, Borough Cllrs Roger Rigby and Jon Gambold.
- 2 Declarations of interest in items on the agenda None
- 3 **To approve the Minutes of the Annual Parish Council meeting** held on 18th May 2021. **Resolved** to approve the minutes of the meeting as an accurate record.

4 Public Open Session

- Parishioner requested assistance from the parish council on behalf of another parishioner to have the signs repaired/replaced for Hampden Court, which are no longer displaying that the road is a dead end Clerk to investigate.
- To receive and discuss speed data from the Speed Indication Device (SID). Parishioner presented the speed data, which is available upon request. Of note was the continued issue of "platooning", which is the disruption to recorded data by cars travelling closely together and being treated as one.
- 5 **Correspondence (requiring council attention):**
 - Parishioner emailed in relation to new bins in St Mary's, which are apparently the parish council's responsibility to select locations. Neither BBC nor Vistry could confirm this. Clerk to revert to parishioner to investigate the issue.

6 **Clerk's report on matters in progress**

- The replacement bench for King's Corner has been ordered but not yet received.
- Request for average speed cameras was provided to Bedford BC Highways confirmed that Biddenham had been added to the waiting list.
- Feasibility study by Highways for pedestrian refuges on Bromham Road was requested by the parish council and will be carried out shortly.
- Clerk and parishioner met with Bedford BC in relation to access to the "Oxbow" lakes to the west of Biddenham. Discussions with the grazier are ongoing.

9 Bus stop on Main Road

Proposal from Cllr Bates: To install a bus stop on the south side of Main Road on the grass verge owned by Wingfield for passengers waiting for and alighting buses. Exact location of bus stop has now been confirmed by BBC and the bus company.

Action: The current bus stops are recorded on the council's mapping software as being directly opposite each other. If a hard standing was installed it would mean buses might block the whole road if stopping at the same time. Clerk to find out if the stop can be moved, and then bring this item back to the next meeting.

10 Highways

- To note the response from BBC Highways in relation to a parish council proposal for an improved layout on Gold Lane. BBC Highways will not support this financially. Clerk to request a site meeting with Highways (Action Clerk). Cllr Briggs to investigate funding options for the work (Action Cllr Briggs).
- To note the attempted resolution of flooding on Biddenham Turn, caused by a combination of blocked AW pipes and a blocked ditch on the golf course land.
 The second blick bankford for the work serviced out has DBC Uichwares (Course Course)

The council is thankful for the work carried out by BBC Highways (Garry Gardner).

14 Coronavirus update


To consider the parish council's response to support of parishioners during the pandemic. No changes to be made to the current approach (Dedicated phone line and whatsapp group).
